Completion and delivery of nows will not preclude you from attending the AGM and votting in person at the AGM if you so wish, but in the event of your attending the AGM after having lodged this form of proxy, this form of proxy will be deemed to have been revoked.
- Where there are joint registered holders of any Share(s) in the Company, any one of such joint holders may vote at the AGM, either personally or by proxy, in respect of such Share(s) as if he were solely entitled thereto.
