**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 28 OCTOBER 2013**

Reference is made to the circular of China Modern Dairy Holdings Ltd. (the “**Company**”) dated 25 September 2013 (the “**Circular**”) in relation to, among other things, general mandates to issue shares and to repurchase shares and re-election of Directors. Unless the context requires otherwise, terms used herein shall have the same meanings as in the Circular.

Poll Results of the Annual General Meeting

The Board is pleased to announce that all resolutions, apart from the resolution numbered 4 below for the grant of a general mandate, were duly passed by the Shareholders attending and voting by way of poll at the Annual General Meeting held on 28 October 2013. The Company’s branch share registrar and transfer office in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the vote-taking at the Annual General Meeting.

As at the date of the Annual General Meeting, the total number of issued Shares in the capital of the Company was 4,818,535,733 Shares. None of the Shareholders were required to abstain from voting at the Annual General Meeting. Accordingly, there were a total of 4,818,535,733 Shares, representing the entire issued share capital of the Company, entitling the Shareholders to attend and vote for or against the resolutions proposed at the Annual General Meeting. There were no Shares entitling the Shareholders to attend and vote only against the resolutions at the Annual General Meeting.
