GRANT OF SHARE OPTIONS

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited.

The board (the “**Board**”) of directors (the “**Directors**”) of China South City Holdings Limited (the “**Company**”) announces that a committee duly authorized by the Board has resolved on 30 June 2014 (the “**Date of Grant**”) to grant share options (the “**Share Options**”) to two Directors and certain employees of the Company and its subsidiaries (the “**Grantees**”) to subscribe for ordinary shares of the Company (the “**Shares**”), subject to the acceptance of such Grantees, under the share option scheme adopted by the Company on 4 September 2009.

A summary of the grant of the Share Options is set out below:

In these Share Options, there are three types of vesting schedules, details as below:

- a. 49,650,000 Share Options will be vested from the Date of Grant;
- b. 51,650,000 Share Options will be vested upon the first anniversary of the Date of Grant; and

c. 2,000,000 Share Options will be vested upon the second anniversary of the Date of Grant.

Among the Share Options granted, 69,300,000 Share Options were granted to Mr. Leung Moon Lam, an executive Director and the chief executive officer of the Company, and 2,000,000 Share Options were granted to Mr. Lin Ching Hua, a non-executive Director of the Company. In accordance with Rule 17.04(1) of the Listing Rules, the grant of the Share Options to Mr. Leung Moon Lam and Mr. Lin Ching Hua has been approved by the independent non-executive Directors of the Company.

Save as disclosed above, none of the Grantees is a Director, chief executive or substantial shareholder of the Company, or any their respective associates (as defined under the Listing Rules) as at the date of this announcement.
