Inside Information Profit Warning

This announcement is made by the board of directors (the “**Board**”) of China South City Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”), investors and potential investors (collectively, the “**Other Investors**”) that, based on the preliminary assessment of the Group's unaudited management accounts for the six months ended 30 June 2024 (the “**1H 2024**”) and other information currently available, the Group is expected to suffer a loss after tax ranging from approximately HK\$4 billion to HK\$4.5 billion in the 1H 2024. The expected loss is mainly due to: (i) decrease in sales and delivery of properties during the Period (ii) fair value losses on investment properties; (iii) increase in inventory impairment provision; (iv) increase in finance cost due to reduce of interest capitalised on properties under development; and (v) decrease in rental income.

The information contained in this announcement is only based on the preliminary assessment of the Group's unaudited management accounts for the 1H 2024 and other information currently available, which has not been audited or reviewed by the auditor or the Audit Committee of the Company, and it could be subject to further adjustments or revisions. The Company's results announcement for the 1H 2024 is expected to be published no later than 30 August 2024. Shareholders and other investors should read it carefully.
