ACTION TO BE TAKEN

To make your election, you may send a notice of intent to the Company in the form of the enclosed instruction slip indicating whether you wish and agree to select one of the various options given to you in the instruction slip. Please tick the appropriate box and sign and return the instruction slip, in the envelope provided, to the Company's branch share registrar in Hong Kong, Tricor Investor Services Limited ("Tricor") at 26th Floor, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong. If your registered address is within Hong Kong, the enclosed envelope will be postage prepaid and you will not need to affix a stamp when returning your instruction slip. Otherwise, please affix an appropriate stamp.

If we receive your instruction slip on or before 22 May 2009, your instructions will apply to all Corporate Communications to be sent by the company to its shareholders on or after 22 May 2009 until you inform the Company otherwise.

However, if we do not receive your instruction slip or if you do not elect any mentioned options by 22 May 2009 and until you inform the Company otherwise by reasonable notice in writing to Tricor, we will only send to you: (a) a printed Chinese version of all future Corporate Communications if your address as shown in the Register of Members of the Company is in Hong Kong and you have a Chinese name; or (b) a printed English version of all future Corporate Communications, if your address as shown in the Register of Members of the Company is overseas, or if you are a corporate shareholder, or if you do not have a Chinese name.

You have the right at any time by reasonable notice in writing to Tricor to change the choice of language of future Corporate Communications.
