D-Link Corporation Announces to Transfer Alpha Networks' Shares to Quanta Computer Inc.

Taipei, March 11, 2004

D-Link Corporation today announces that it will transfer 42.5mln shares of Alpha Networks' shares to Quanta Computer Inc. on March 15, 2004. This equals to 17% of the total outstanding shares of Alpha Networks, at the price of NT\$ 25 per share with the total transaction valued at NT\$ 1,062.5mln. The transaction will result one seat for Quanta Computer on Alpha Networks' Board. Full-scale cooperation between Alpha and Quanta in the fields of R&D, manufacturing, sales and marketing will take place following the deal.

D-Link stipulates that in line with Alpha Networks' public listing scheduled by the end of June 2004, it has been D-Link's policy to transfer portions of its holding of Alpha to strategic partners. Quanta Computer has from every perspective the complimentary synergy to be a most ideal strategic partner to Alpha Networks. D-Link thus has made the strategic move to sell part of its stake of Alpha to Quanta.

Alpha Networks, an OEM/ODM spin-off from D-Link, is the leading networking DMS company in Asia, which possesses solid core Ethernet technology and the most comprehensive product lines. "Our cooperation with Quanta Computer, be it products, manufacturing, cost containment and global logistics, are extremely complimentary in light of the convergence of the computer and network communication industries." said Mr. John Lee, Chairman of Alpha Networks.

友訊宣佈轉讓明泰股權予廣達

友訊科技股份有限公司今日(11日)公告宣佈於3月15日轉讓其子公司明泰科技股份有限公司(以下稱「明泰」)百分之十七之股權，合計4,250萬股予廣達電腦股份有限公司(以下稱「廣達」)，轉移價格每股新台幣25元，合計新台幣10億6,250萬元，廣達將取得一席董事席位。廣達與明泰將在研發、製造、行銷各方面充份地合作。

友訊表示，配合明泰預訂於6月底上市，將明泰股權轉讓予策略性投資人為既定政策。廣達與明泰多方面有互補優勢，為理想的策略結盟夥伴，故決定釋股予廣達。

明泰為國內網路設備領導廠商，擁有完整的核心技術與全線產品，「在電腦與通訊整合的趨勢下，廣達在產品開發、量產製造、成本控制及後勤系統上，與明泰有明顯綜效。」明泰董事長李中旺表示。
