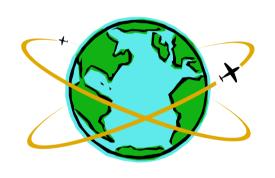

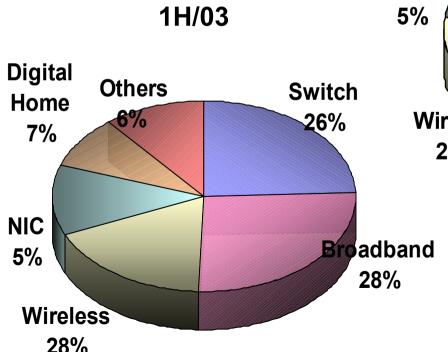

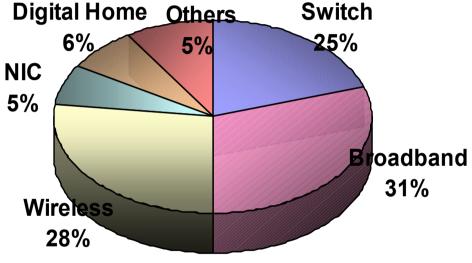


2Q At a Glance -- Revenue by Products

➤D-Link accounted for 14.5% of worldwide SOHO/Home WLAN market shares (by Synergy).



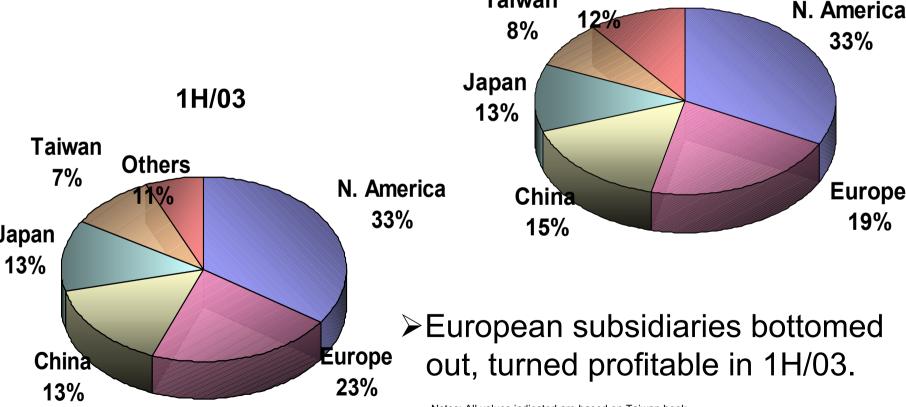
2Q At a Glance -- Revenue by Regions

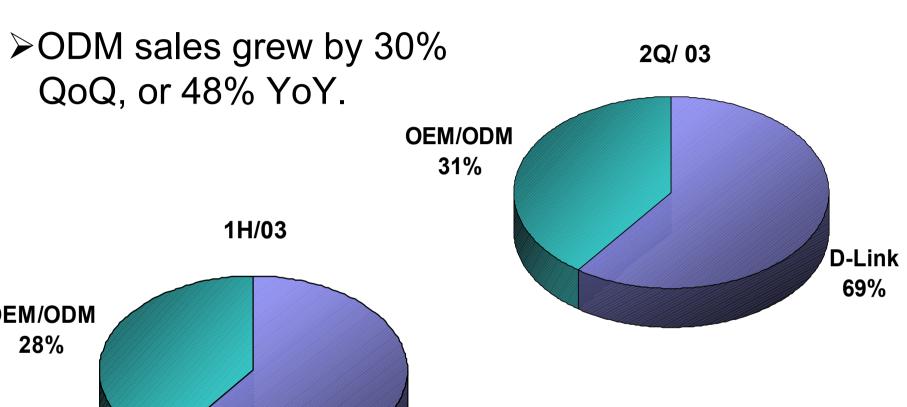

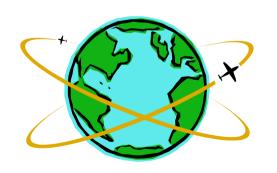
