

## **D-Link Reports Fourth Quarter 2024 Financial Results**

Taipei, February 26, 2025- D-Link today announced its net revenue of NT\$3,431 million for the fourth quarter 2024, a decrease of 7.5% YoY; Gross profit was NT\$867 million, an increase of 15.6% YoY; D-Link's 4Q24 operating loss was reported at NT\$176 million. D-Link's fourth quarter net loss was NT\$80 million, net loss attributable to owners of parent was NT\$111 million, and EPS was NT\$-0.19.


With respect to 4Q24 consolidated revenue by product category, Switch & Security products accounted for 46% of sales revenue, followed by Wireless & IoT at 8%, Mobile & Broadband at 9%, and Others at 37%. From a geographic perspective, 4Q24 revenue contribution from Europe and America were 27% and 6% respectively, and from Asia Pacific & Others was 67%.

Note: The Company commenced controlling Cameo Communications, Inc. as a subsidiary on April 1, 2023.
