

## Alpha Networks Inc. Reports Fourth Quarter 2025 Results

Hsinchu, Taiwan, February 25, 2026 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the fourth quarter 2025.

In the fourth quarter 2025, the consolidated revenue was NT\$6,407 million, increased 9.8% from last quarter. Wireless Broadband accounted for 37% of consolidated revenue, followed by LAN/MAN at 35%, Digital Multimedia at 7% and others at 21%. Gross profit increased 16.2% to NT\$1,182 million quarter-over-quarter. Operating expenses increased 11.7% to NT\$1,107 million quarter-over-quarter. Operating income was NT\$75 million, or 1.2% of consolidated revenue. Net income was NT\$73 million. Net income attributable to shareholders of the parent company was NT\$7 million, or NT\$0.01 per share, decreased NT\$0.01 quarter-over-quarter.

In 2025, the consolidated revenue was NT\$22,462 million, an increase of 4.7% year-over-year. Wireless Broadband accounted for 43% of the consolidated revenue, followed by LAN/MAN at 37%, Digital Multimedia at 8% and others at 12%. Gross profit decreased 0.8% to NT\$3,897 million year-over-year. Operating expenses were NT\$4,034 million or 18% of consolidated revenue, a increase of 5.6% year-over-year. Operating loss was NT\$137 million, or -0.6% of consolidated revenue. Net loss was NT\$147 million. Net loss attributable to shareholders of the parent company was NT\$194 million, or NT\$-0.36 per share, a decrease of NT\$0.76 year-over-year.
